



**Northwest Missouri State University
Board of Regents
Open Meeting Minutes
October 20, 2023**

The Northwest Missouri State University Board of Regents met at 10:30 a.m. on October 20, 2023, pursuant to public notice given October 16, 2023.

The following members of the Board were present: Steve Coppinger, Shanda Durbin, John Moore, Elizabeth Motazed, Debbie Roach, Roxanna Swaney and Mel Tjeerdsma. Also present were: President Dr. Lance Tatum, Vice President of Student Affairs Dr. Matt Baker, Vice President of Finance and Administration Stacy Carrick, Vice President of Culture Dr. Clarence Green, Athletic Director Andy Peterson, and Legal Counsel Tanya Wilson.

A quorum being present, Chair Swaney called the meeting to order at 10:33 a.m. Roll call was taken.

 - On November 11, 2023, the Student Senate will be hosting an alumnus gathering for former presidents of the Student Senate.
 - The Senate has filled most of the vacancies, and are looking to fill our Sergeant in Arms, Chief of Staff, and Parliamentarian position.
- Ms. Selena Foreman, Staff Council Chair
 - The t-shirt fundraiser raised \$1,334 dollars to go towards the Northwest Staff Council Scholarship.
 - Stress Less Fest held Walk Out Day, 1-4 pm, at the Bell Tower for staff and faculty.
 - Staff Council sponsored dress up days during Homecoming Week.
 - Residential & Auxiliary Services is now selling mailboxes from Phillips Hall and North Complex, which are available on the Marketplace.
- Dr. Rhonda Beemer, Faculty Senate President
 - Our 50th faculty senate has met 4 times this academic year:
 - Committees for faculty senate are also meeting regularly.
 - Notable activities currently taking place that involve faculty senate include a call from the Research Committee for Theoretical and Applied research proposals for funding during this fiscal year. The Teaching and Learning Committee is assisting with Faculty Development days and today is the last day for employees to submit proposals to present during the January meeting. Our Curriculum and Degree Requirement committee has been very productive with the review and approval of several course changes, new course developments, and new programs. Eleven proposals have been approved so far by the faculty senate and were sent to the Board of Regents for approval. We will have several proposals to discuss during our next few meetings. Finally, faculty senate has offered recommendations to our Faculty member represented on the University Calendar committee.
