



**Northwest Missouri State University  
Board of Regents  
Open Meeting Minutes  
December 7, 2023  
approved on March 18, 2024**

The Northwest Missouri State University Board of Regents met at 9:30 a.m. on December 7, 2023, pursuant to public notice given November 30, 2023.

The following members of the Board were present: Shanda Durbin, John Moore, Elizabeth Motazedi, Debbie Roach, Roxanna Swaney and Mel Tjeerdsma. Also present were: President Dr. Lance Tatum, Vice President of Finance and Administration Stacy Carrick, Vice President of Culture Dr. Clarence Green, Provost Dr. Jamie Hooyman, Vice President of Advancement Mitzi Marchant, Athletic Director Andy Peterson, Assistant Vice President of Finance Mary Collins, Assistant Vice President of Student Affairs Dr. Rose Viau, and General Counsel Hayley Hanson.

A quorum being present, Chair Swaney called the meeting to order at 9:31 a.m. Roll call was taken.

  - The Student Senate wants to focus on developing and maintaining relationships with our past members and alumni. With that, I have created a Facebook group where former members are able to join and stay up to date with what we are doing and our events.
  - The application for the next student regent was opened to fill the spot for when I graduate. This application was open to any and all NW students who fit the criteria. Next semester, the applicant(s) will undergo the interview process and we will submit those names for review to the capital.
- Ms. Selena Foreman, Staff Council Chair
  - Staff Council partnered with the Northwest Foundation to co-sponsor the annual Holiday Tea, which is an appreciation event for current and retired Northwest employees.
  - Five staff members are graduating with degrees from Northwest this semester: Westly Bertha, Matthew Cannella, Ann Heidendal, Tess Lovig, Rachel Peter
  - Welcomed new staff council representative Nicole Falcone, and currently have two positions open
  - Submitted names for a staff member to serve on the inauguration committee.
- Dr. Rhonda Beemer, Faculty Senate President
  - Faculty Senate officers have recently heard some concerns mostly to do with salary.
    - Faculty are awaiting the results/recommendations of the salary study.
    - The salary blue book has not been updated and posted on the Missouri website since 2019.
      - This strengthens concerns that some faculty are having and could potentially weaken our candidate pool for future faculty hires.
  - Because of this, Faculty Senate would like to highlight activities and processes we have in place to assist faculty.
  - The Faculty Welfare and Budget committee has created a document that can be found on myNorthwest called the Faculty Grievance Reference Guide.
  - Faculty senate encourages faculty to communicate with our various committees. We have encouraged faculty with any concerns to communicate with their faculty senators, Human Resources, the Provost's Office, or if needed, to file a comment card online.
  - Faculty Senate meetings are usually held the 1st and 3rd Wednesdays of the month and are open for anyone to attend. To make things more available to faculty, we will now be supplying a zoom link for anyone that would like to attend, but cannot be in person. This will be for non-voting individuals.
  - All committees have been meeting throughout the semester.


