

Northwest Missouri State University Board of Regents Open Meeting Minutes August 2, 2024 Approved Oct. 3, 2024

The Northwest Missouri State University Board of Regents met at 1:00 p.m. on August 2, 2024, in the J.W. Jones Student Union Boardroom, pursuant to public notice given July 26, 2024.
