

Northwest Missouri State University Board of Regents People, Finance and Operations Committee Open Meeting Minutes October 1, 2024 Approved December 10, 2024

The Northwest Missouri State University Board of Regents People, Finance and Operations Committee met in open session via Zoom on October 1, 2024, pursuant to public notice given September 26, 2024.

The following members of the People, Finance and Operations Committee were present: Shanda Durbin, John Moore and Roxanna Swaney. Also present were Regent Steve Coppinger, President Dr. Lance Tatum, Vice President Dr. Matt Baker, Interim Vice President Krista Barcus, Vice President Stacy Carrick, Provost Dr. Jamie Hooyman, Vice President Mike Johnson, Athletics Director Dr. Andy Peterson, Assistant Vice President Counsel Hayley Hanson.

Roll call was taken at 10:01 a.m. Quorum was established. It was decided Vice Chair Coppinger will vote in place of absent committee member, Mel Tjeerdsma, as prescribed in Article X of the Board's bylaws.

FYI's

President Tatum presented the following FYI's to the committee:

- The Office of Student Involvement received a score of 33.7 out of 36 for our All In Campus
 Democracy Engagement Action Plan from Civic Nation. This earned our campus the Highly
 Established Action Plan Seal. Special thanks to Garrison Kennedy for leading the coalition to
 develop and put this action plan in place.
- Jim Gulbranson has resigned as Assistant Director- Fraternity & Sorority Life. His last day on campus was September 4th. The search process for his replacement has begun.
- Residential and Auxiliary Services had ~325 upper-class students volunteer as Cat Crew members on freshman move-in day.
- Title IX and Equity already has accommodations in place for 3 expecting students with several faculty reaching out to us with additional referrals based on the newly approved Pregnancy Accommodations Policy.
- University Advancement updates
 - FY24 fundraising through July 31, 2024: \$562,450
 - Martindale project funding as of August 28, 2024:
 - Fundraising commitment from Foundation: \$3 million
 - Amount raised to date: \$3.02 million
 - Mike Johnson began as the Vice President of University Advancement on August 5.
 - Powering Dreams, the annual event that celebrates scholarship donors and recipients, was held on Sunday, Sept. 29, at the Agricultural Learning Center.
 - The next Northwest Foundation Board of Directors meeting is Oct. 17-18.
 - The Tourin' Bearcats Alpine Lakes and Scenic trains trip is already full with 44 travelers registered. It is scheduled for June 1-11, 2025.
- U.S. News and World Report regional rankings improved from last year.
- Compensation Task Force consisting of 16 members kicked off with a meeting on Sep 30.
- 100th Homecoming is October 19.
