



**Northwest Missouri State University
Board of Regents
Open Meeting Minutes
December 12, 2024
Approved on March 20, 2025**

The Northwest Missouri State University Board of Regents met at 1:00 p.m. on December 12, 2024, in the J.W. Jones Student Union Boardroom, under public notice given December 6, 2024.

The following members of the Board were present: Steve Coppinger (joined by phone), Shanda Durbin, Jason Klindt, John Moore, Debbie Roach, Roxanna Swaney, and Mel Tjeerdsma (joined by phone). - End of Semester totals:
 - We appropriated \$13,340.09 to 13 student organizations, allowing them to attend conferences or host events on campus. This has used just over 50% of our Organizational Finance budget for the year, so we are right on track.
 - We approved the formation of 10 new student organizations this semester.
- We are beginning planning for our annual Legislative Reception. This year, we will attend Jefferson City on February 25th – 26th. At the Legislative Reception, Senators get the chance to tour the capitol and meet with different Missouri Legislatures.
- Finals are wrapping up and the students are excited for graduation or a nice winter break!
- Commencement ceremonies are Friday, December 13th at 10:00AM and 2:00PM.

On behalf of the faculty at Northwest Missouri State University, I extend our gratitude for your unwavering support of our academic endeavors. Your leadership and dedication to advancing the mission of our institution enable us to educate, inspire, and guide our students as they strive to achieve their full potential as Bearcats. I am honored to present this semester's Faculty Senate Report, which highlights the impactful work our faculty have accomplished in teaching, research, and service, while also addressing how we are adapting to emerging challenges.

Innovative Teaching and Academic Excellence

Our faculty are continually finding creative ways to engage students and deepen their understanding of complex subjects. A shining example this semester is the Research Seminar in History (HIST 33591), which embraced a groundbreaking approach to studying ancient civilizations.

Recognizing the growing interest in video games as both a cultural force and an educational tool, this course used popular video games as a lens to examine the Greco-Roman world. Students critically analyzed how these games represent key historical aspects, such as art, architecture, social structures, and the environment. Through over 1,000 hours of gameplay and analysis, students explored the narratives these games tell, their educational value, and their potential for shaping public understanding of history. As a culmination of the course, students applied their learning by developing their own video game concepts, each designed to teach audiences about specific facets of ancient history. This capstone project combined rigorous historical analysis with creative problem-solving, demonstrating how technology and storytelling can bring the past to life for modern audiences.

This innovative teaching method not only aligns with the rising popularity of video games as a medium but also addresses their role in education and cultural dialogue. With the global gaming industry surpassing \$200 billion annually, opportunities for education and engagement through gaming have never been greater. The success of this course highlights how Northwest faculty are leveraging these trends to prepare students for dynamic and interdisciplinary careers.

Faculty Research and Scholarly Contributions

Our faculty continue to excel in research, addressing some of today's most pressing challenges and contributing to their respective fields. A sampling of this semester's approved research projects span a variety of disciplines:

- Health and Wellbeing:

 - *Impact of an On-Campus Sensory Space*
- Education and Counseling:

 - *An Investigation of the Relationship between Teacher Self-Efficacy and Burnout, Secondary Trauma, and Compassion Fatigue*
 - *The Impact of Needs Assessment for Tier One Instruction in an Elementary School Setting*
- Social and Behavioral Studies:
 - *That's What She Said: Navigating Toxic Comfort and Intrapersonal Communication in Survivors of Sexual Violence*
 - *Effects of Social Media Use on Adolescent Girls' Body Image and Self-Satisfaction*
- Sustainability and Agriculture:
 - *Alternative Fabrication and Processing Strategies to Improve Palatability and Consumer Demand of Underutilized Beef Briskets*
- Political and Global Perspectives:
 - *Exit Poll 2024*
 - *Global Literacy Mandates and Programmatic Changes*

These projects reflect the breadth of faculty expertise and their commitment to addressing complex societal questions.

We have been appraised of needs for a Masters of Public Administration program and we are pleased to inform the Board that we will be proposing a new Masters of Public Administration degree. The program is responsive to needs as indicated by our partners, Risepoint. This program represents an important credential/educational value, preparing people to work in government administration and other similar functions. The need in this area is high as well so not only is the university served by this, but the region is as well.

Addressing Emerging Challenges: Artificial Intelligence

One of the most pressing developments impacting higher education is the rapid evolution of Artificial Intelligence (AI). At Northwest, we are actively engaging with the challenges and opportunities AI presents. Next semester, the Faculty Senate will propose the creation of an interdisciplinary minor in Artificial Intelligence. This program will equip students with a comprehensive understanding of AI, addressing its applications, implications, and ethical considerations across multiple fields of study.

In addition, I have been collaborating with Dr. Cagg, Dr. Runyon, and Dr. Allard to develop a comprehensive set of AI policies for the university. Tentatively titled *Guidelines and Guardrails*, this document will provide actionable recommendations to address AI's influence on academic integrity, pedagogy, and institutional operations. Our goal is to ensure that Northwest remains a leader in navigating this transformative technology responsibly.

As we reflect on these achievements and initiatives, we remain deeply grateful for the support of the Board of Regents. Your investment in faculty research, teaching, and innovation enhances the academic experience for our students and enables us to address emerging challenges with confidence. Together, we continue to fulfill our shared mission of preparing students for lives of purpose and leadership. In closing, I thank you for your steadfast commitment to Northwest Missouri State University. The faculty


