



**Northwest Missouri State University
Board of Regents
Open Meeting Minutes
March 20, 2025
Approved on May 2, 2025**

The Northwest Missouri State University Board of Regents met at 1:00 p.m. on March 20, 2025, in the J.W. Jones Student Union Boardroom, under public notice given March 13, 2025.

The following members of the Board were present: Shanda Durbin, Jason Klindt, John Moore, Debbie Roach, Roxanna Swaney, and Mel Tjeerdsma (joined by phone). - **Ms. Chloe DeVries, Student Senate President**
 - Elections for the 103rd Student Senate are taking place next week. Students will receive a ballot to vote in their student emails.
 - After next week, the focus will be on transitioning the next Student Senate leaders.
 - Our spring blood drive will be April 22nd and 23rd!
 - Student Senate has appropriated funding to 13 organizations this semester, totaling \$12,939.03
 - We have funding left for 1-2 more organizations.
 - A recap of our year will be reported at the next Board of Regents meeting.

- **Dr. Rob Voss, Faculty Senate President**

Since the start of the spring semester, faculty have continued to engage in meaningful efforts to support student success, enhance institutional excellence, and advocate for the long-term well-being of Northwest Missouri State University.

Faculty remain committed to maintaining Northwest's high academic standards while actively engaging in institutional decision-making. This semester, we have taken on several key initiatives:

- Faculty representation on the Compensation Taskforce has been critical as we work toward developing a fair and sustainable compensation philosophy. We appreciate President Tatum's commitment to including faculty voices in this process, especially those with expertise in human resources and business. The work has been both rewarding and eye-opening, and as forthcoming findings will show, we face significant challenges in faculty compensation.

The reality is that faculty salaries have not kept pace with inflation, and our extra-duty pay structures, such as summer teaching and overloads, have not been meaningfully adjusted to reflect economic realities. While we understand the constraints of the budget, addressing

these issues is essential for faculty retention, morale, and the long-term competitiveness of Northwest. We are working alongside administration to ensure that the taskforce's recommendations are both financially viable and aligned with the needs of faculty and the university.

- In partnership with the Provost's Office, the Faculty Senate's Research Committee is actively organizing the Celebration of Scholars, our annual showcase of student research and academic achievement. Faculty have been nominating outstanding student work, and we invite each of you to return to Northwest on Thursday, April 3, to see firsthand the incredible scholarship being produced by our students. Events like these highlight the high-impact learning experiences that define a Northwest education and reinforce the value of faculty-student collaboration.
- The Faculty Welfare and Budget Committee remains focused on identifying and addressing key challenges facing faculty, including workload balance, professional development opportunities, and financial concerns. Their work is integral in advocating for faculty needs and ensuring that we continue to support the individuals who make Northwest a leader in student-centered education.
- Faculty Senate is undergoing an internal restructuring to align with the university's Academic Redesign efforts. We fully support President Tatum and Provost Hooyman's efforts to restructure academic units in a way that provides greater balance and increased visibility across disciplines. While this process requires adjustments within Senate, including a delay in some elections for representatives, we see it as an opportunity to refresh and strengthen our governance structure. This restructuring is a necessary and positive step in ensuring that faculty representation continues to be effective under the new academic framework.

Northwest faculty are deeply committed to student success, research, and institutional progress. However, as we take on these initiatives, we also recognize that faculty must be supported—both in terms of compensation and in ensuring that workload expectations remain sustainable. The work we are doing now will have lasting impacts on the university's future, and we appreciate the Board's continued support in addressing these challenges.

- **Mr. Duane Havard, Staff Council Chair**

- The Staff Council Outreach Committee held a cookie sale on Valentine's Day to raise money for our scholarship program with over \$500 raised to add to the fund.
- The Outreach committee also selected 4 students to receive a scholarship for the 2026 fiscal year. Those names will be released once they are notified.
- Northwest Staff Council held a Spring Sips event on March 12 at Buffalo Wild Wings GO for Northwest staff members. The Employee Recognition committee organized the event and provided food and drinks for attendees for both the day and night shift employees.

These suggestions will be taken to the Northwest leadership team for discussion and consideration once they are finalized.

- FY25 fundraising through March 19, 2025: \$2.75M & 3,596 gifts committed....highlighted by adding another endowed professorship, this one in Chemistry.
- Comprehensive campaign planning & stakeholder engagement continues to progress nicely, with a focus the university's three overarching initiatives:

- Scholarships: Student Support
- Academic Excellence: Faculty and Programming Endowment...enhancing the collegiate experience!
- Capital Projects: Aligning projects and priorities to the University's strategic and master facility plan.
- Campaign Counsel RFP: Campaign Counsel is on the street in hopes to hire a consultant by July 1, 2025. Priority activities will include an internal assessment of campaign readiness followed by an external feasibility study.
- President Tatum, NWF President-Elect Angela Moskow and VP of Univ. Advancement Mike Johnson attended the Association of Governing Boards (AGB) leadership conference in Washington DC in late January and found it to be a very worthwhile experience. Valuable insights and best practices were gained from sessions focused on strengthening governance, enhancing endowment management, and growing fundraising, to name just a few.
